Resolution No. 22-005 Notice of hearing for 2023 budget adoption

Erik reported that resolution #22-005 is a notice of hearing to adopt the 2023 budget for the Chehalis River Basin Flood Control Zone District. The hearing will be held on Tuesday, December 6, 2022 on or after 3:30 pm at the Lewis County Courthouse in the hearing room to formally adopt the 2023 budget for the district.

The Notice of public hearing will be published in the Chronicle on November 24 & December 1, 2022 and in the East County Journal on November 30, 2022.

He said the 2023 budget will be a rollover of funds already approved by the Office of the Chehalis Basin board and other sources.

Motion made by Supervisor Grose to approve Resolution No. 22-005 notice of hearing to adopt the 2023 budget for the Chehalis River Basin Flood Control Zone District. Supervisor Swope seconded the motion.

Motion approved 2-0.

Office of the Chehalis Basin update

Erik reported that the Office of the Chehalis Basin Board meeting for November 3 has been canceled. The next meeting will be held on December 1.

Edna Fund discussed the flood warning system training that will be held on November 2 from 6:00 to 7:00 p.m. She encouraged everyone to sign up for the training.

Edna also said she would be meeting with Tyson Johnston of the Quinault Indian Tribe to discuss the biennium budget this week.

The Lewis County annual flood meeting will take place on Thursday, November 3 at the Jester's Auto Museum from 1:00 to 4:30 p.m. Erik said he would be giving a presentation at the flood meeting.

Erik said he spoke with Ross McDowell, Department of Emergency Management Director and Ross had listened to the "Future flood" presentation that the Office of the Chehalis Basin (OCB) did. His department has some questions regarding how the flood warning system and how that coordinates with things Lewis County is doing from an emergency management response standpoint. Erik is trying to get him in touch with Andrea McNamara Doyle or someone from OCB or the Flood Authority to better understand these entities are doing on flood warning systems so they are not duplicating efforts.

The group further discussed the flood warning systems and the ownership of them.

Project update

Matt Dillin said the district is still looking at the upstream and downstream minimization alignments. The original alignment is impacting a sensitive cultural resource and the district is trying to minimize the impact with the upstream and downstream alignments. The district is not seeing any issues from a geotechnical standpoint. HDR has been out in the field investigating the bedrock and soil materials and they have not seen any issues. They are also moving to the next phase of geotechnical investigation which is drilling.

Matt discussed the open channel fish passage during the construction phase. This will minimize the impacts to fish during construction. He discussed the design of the open channel fish passage.

He also briefly discussed the 106 consultation with the tribes. He said one of their concerns was visual impact from the structure. He noted the district is getting closer to making a decision on one of the alignments once all the information is received.

Erik said the timeline for the alignment decision is February or March.
