Resolution No. 22-006 Adopting the Annual Budget of the Chehalis River Basin Flood Control Zone District for Calendar year 2023

Supervisor Pollock called the public hearing to order for Resolution No. 22-006 approving and adopting the 2023 Annual Budget of the Chehalis River Basin Flood Control Zone District.

Lara gave the staff report and said the hearing pertains to the recommendation to adopt the 2023 Chehalis River Basin Flood Control Zone District budget as indicated in proposed Resolution No 22-006.

Notice of this public hearing was published in the Chronicle on November 24 and December 1, 2022 and in the East County Journal on November 30, 2022.

Lara noted that revenues will be budgeted at \$4,214,350 and expenditures will be budgeted at \$4,214,350 as indicated in attachment A.

There are three main revenue sources:

RCO funding for the Chehalis Basin Strategy-\$4,147,350

RCO funding for the Hyporheic Exchange project - \$20,000

.09 Distressed Counties funding for social media and communications outreach-\$47,000

Total funding sources-\$4,214,350

Matt Dillin reviewed attachment A.
